TC 55/18 Police Report

TC 56/18 Town Councillor Vacancy, Sunnydale Ward, Shildon – Co-option

The Town Clerk advised Members of a vacancy in the Sunnydale Ward of Shildon Town Council following the resignation of Matt Johnson and informed Members that Durham County Council did not receive the requisite number of signatories to call an election for the vacancy. The vacancy could now be advertised and filled by co-option.

It was proposed and seconded that Rachael Ann Anderson be co-opted onto Shildon Town Council.

- b. Rachael Ann Anderson be co-opted as a Councillor for Sunnydale Ward, Shildon.

TC 57/18 Consultation on Proposal to Remove Street Lights : Lambton Street (Junction with A6072) Shildon Bypass

The Town Clerk informed Members of a consultation on the proposal to remove street lights at Lambton Street (junction with A6072), Shildon.

Resolved that

- a. the retention of lighting columns LC1365, LC1366, and LC1367 be noted.
- b. Durham County Council be requested to retain either lighting column LC1369 or LC1370, whichever is the closest to the public footpath, to illuminate public right of way no. 50 which is frequently used by residents.

TC 58/18 Nomination : National Association of Local Councils Larger Councils Committee

The Town Clerk informed Members that following a request from the National Association of Local Councils to re-nominate Councillor P Quinn for a councillor vacancy on the Larger Local Councils Committee for 2019/20, Councillor P Quinn had been re-nominated for a vacancy on the Committee and the nomination had been submitted to NALC.

Resolved that the action of the Town Clerk in re-nominating Councillor P Quinn for a vacancy on the NALC Larger Local Councils for 2019/20 Committee be endorsed.
